

# **COOLER™** Performer Data



Our overall student performer data was gathered from pre- and postevaluation forms filled out by both the teachers and the parents of the students in the My5tery Music™ performing arts programs. The "Start" numbers denote the averages of the parents' and teachers' observations of the students' character in those specific categories before they joined My5tery Music's performing arts programs.

The "Finish" numbers denote the averages of the parents' and teachers' observations of the students' character in those specific
